Between April 2-28, 9,639 people were reached through Facebook posts on the Chamber's page.

A total of 58 new people "liked" the page in April, and 59 people followed the page.

Post engagement (clicks or actions on posts) totaled 3,980 in April. Just this week, top posts reached over 700 people.

This past week, The Chamber's Facebook page ranked just below the Onslow County Partnership for Children page, with 30 posts and 1.8K engagements. The Chamber ranked No. 2 out of five local pages with similar interests, including the United Way.

Profile visits to the Chamber's Twitter page were up 20 percent this month. Tweet impressions totaled 5,023 in April.

This is based on organic engagement statistics from Facebook, without paid promotions.

Website

According to Google analytics, approximately 2,000 users visited the Chamber website in April. On average, 476 people visit the website each week. Almost 60 percent of website users are visiting the website on a desktop computer, while 34 percent use a mobile device. Only 5 percent of our visitors are using a tablet to research the Chamber of Commerce.

Popular pages on the website include Pink Trash's profile and the Service Member of the Month page.

MILITARY AFFAIRS COMMITTEE

The Committee's purpose is to maintain and continually improve the relationship between the military and civilian communities.

April's Service Member of the Month Sergeant Benjamin J. Wanzy, USMC

Sgt Benjamin Wazny is distinguished as the Service Member of the Month (SMOM) for the month of April by the Jacksonville•Onslow Chamber of Commerce Military Affairs Committee.

Benjamin Wazny enlisted into the Marine Corps in January of 2011 and attended Recruit Training at Parris Island, South Carolina, graduating in April 2011. Pvt Wazny attended Infantry Training Battalion (ITB), School of Infantry-East (SOI-E), Camp Geiger, North Carolina, where he became an Infantry Assaultman in July of 2011. Immediately upon graduating, he was assigned to Company E, 2nd Battalion, 6th Marine Regiment, 2d Marine Division for duty as a Gunner in the company assault section.

In November 2011, PFC Wazny was deployed to Treknawa, Afghanistan, in support of Operation Enduring Freedom. After his return, he was assigned as Squad Leader for the Assault Section. In October 2012, LCpl Wazny attended Advanced Assaultman Course (AAC) at Advanced Infantry Training Battalion (AITB), SOI-E.

In August of 2013, he was deployed to Okinawa, Japan, as part of a Unit Deployment Program (UDP). After his return, he was promoted to Corporal on April 1, 2014. Cpl Wazny attended Marine Corps Martial Art Program (MCMAP) at AITB, SOI-E, and graduated October 28, 2014. In November of 2014, he was assigned as Section Leader for the Assault section.

In September of 2015, he was promoted to Sergeant and soon after deployed on the 26th Marine Expeditionary Unit (MEU) in support of Operations Inherent Resolve (OIR). Lower Cape Fear Hospice received the 2019 Hospice Honors support to patients and their families. It is rewarding to see Elite recognition from HEALTHCAREfirst yesterday at the National Hospice and Palliative Care Organization's Leadership and Advocacy Conference in Washington, D.C.

Each year, HEALTHCAREfirst conducts a review of the Hospice Consumer Assessment of Healthcare Providers and Systems (CAHPS) survey results, which ask hospice patients' caregivers and families about their satisfaction with hospice services and other feedback. Hospices receive a score on 24 quality indicator measures, and the review compares each individual hospice's performance score for each measure to the national performance score based on all hospice information available.

Hospice organizations which score above the national HEALTHCAREfirst performance score on 20 of the 24 evaluation questions receive the Hospice Honors designation. Organizations which score above the national HEALTHCAREfirst performance score on all 24 of the evaluated questions receive the prestigious Hospice Honors Elite recognition.

Lower Cape Fear Hospice (LCFH) has received the 2019 Hospice Honors Elite recognition, meaning it scored above the national performance score on all evaluation questions during the October 2017 to September 2018 evaluation period.

LCFH is the only local hospice provider to have received the Hospice Honors Elite recognition.

"This is wonderful news," said Gwen Whitley, President and CEO of Lower Cape Fear Hospice. "Our team works hard every day to provide the highest level of care and



Onslow County Tourism is contracted out by the county and is managed by the Jacksonville/Onslow Chamber of Commerce. The Chamber exists as a voice for business in Jacksonville and Onslow County, and together we share the same vision in vigilant and focused efforts in generating economic impact and connecting local business, military and community; for the benefit of our residents as well as our visitors.

in marketing and management decisions. I feel that our community therefore needs to understand the relative importance of tourism to our region, including tourism's contribution to economic activity in the area.

Visit North Carolina announced in August 2018 that domestic visitors to and within Onslow County spent \$231 million in 2017, a 3.78% increase from 2016. This spending captures sales and occupancy tax collection by visitors and the value of our employees within the industry. Onslow's travel and tourism industry directly employs more than 1,800 personnel with a payroll generating \$45.8 million in Onslow County.

State tax revenue generated in Onslow County totaled \$12 million through state sales and excise taxes, and taxes on personal and corporate income. About \$8.83 million in local taxes were generated from sales and property tax revenue from travel-generated and travel-supported businesses.

Community support is important for tourism, as it's an activity that affects the entire population. Tourism businesses depend considerably on each other as well as on other businesses, government and residents of the local community. Economic benefits and costs of tourism reach virtually everyone in the region in one way or another.

Together, the Jacksonville Onslow County Chamber and Onslow County Tourism has great relationships with our tourism partners that support putting Onslow's best foot forward. It's been an incredible experience promoting Onslow County's tourism partners...as our fiscal year ends I look forward to, with enthusiasm, the support we seek to support a prosperous 2019/2020 fiscal year.
